NR 505 Week 2 PICOT Worksheet Assignment

In this assignment, students will develop their understanding of the development of a PICOT statement that can be used as a springboard for the critique of evidence from scholarly [NURS FPX 3200 Assessment 4 Attempt 1 Robbing the Dead: Is Organ Conscriptio Ethical?](#) sources. PICOT stands for population, intervention, comparison, and outcome.

Using the area of interest from Week 1, formulate a clinical question using the PICOT format. Identify key terms to search for evidence in scholarly databases.

P-Population and Problem

The PICOT Worksheet Assignment provides students the opportunity to identify a nursing practice concern/problem and related nursing theory for their EBP project. This will allow the student to construct a PICOT question, and identify key terms for conducting a literature search of evidence within the scholarly database.

The PICOT format identifies the population impacted, the problem/concern, the intervention, the comparison, and the outcome, and a timeframe for accomplishment of the identified issue. The [COM FPX 1250 ASSESSMENT 2 Attempt 1 Written Communication: Writing an Email](#) statement should be written in standard, narrative format and each element defined clearly. A minimum of 2 scholarly sources should be used to support the PICOT question. A completed worksheet is due Sunday at 11:59 p.m. MT. Students are encouraged to complete the worksheet and provide a link to it in Doc Sharing for submission. Each step of the process should be documented in detail on the worksheet as the search is conducted. This will help to ensure that the search is complete and comprehensive.

I-Intervention

Across the healthcare industry, evidence is used to shape and direct nursing practice in order to improve health outcomes and organizational efficiency. As an MSN student, you will learn to apply a research-based approach to your practice through a model known as evidence-based practice (EBP).

To start, you will develop your PICOT question for the clinical inquiry that will serve as your EBP project. Clearly define each element of the clinical inquiry in the standard PICOT question format: P-Population and Problem, I-Intervention, C-Comparison, and O-Outcome.

Then, identify the appropriate search terms to help you find the relevant scholarly literature. Be sure to use a minimum of two scholarly sources. Your PICOT statement will provide a foundation for your Week 7 assignment to foster a proposed evidence-based practice intervention. [ACC 5301 Unit I Management Applications of Accounting](#) will also be asked to reflect on the significance of the selected issue to nursing and/or healthcare in general. You will complete the Week 5 Evidence-Based Practice Searchable Clinical Questions Form as you conduct each search.

C-Comparison

This assignment provides the opportunity for students to identify an area of concern/problem related to their selected MSN specialty track. In this assignment, students will explore the development of a PICOT statement that can serve as a springboard for the critique of scholarly evidence surrounding the identified practice problem and intervention to improve outcomes.

Clearly characterize your clinical inquiry using the standard PICOT question format: P-Population and problem, I-Intervention, C-Comparison and O-Wanted outcome. This assignment will prepare you for the Week 7 assignment that will foster a proposed evidence-based nursing (EBP) intervention.

Complete the NR 505 Week 2 PICOT Worksheet. Use the Doc Sharing link to submit your submission. Complete this form as you conduct your literature search. The worksheet will also help you identify [NURS FPX 6105 Assessment 1 Learning Theories and Diversity](#) search terms for your literature review. You must use at least two (2) scholarly sources in your response. Identifying these search terms will help you identify articles that may support your EBP project.

O-Outcome

Using the PICOT worksheet, students will review elements that are included in PICOT statements to guide evidence-based practice. Then, students will select a practice concern/problem and nursing theory related to their MSN specialty track. They will identify the practice issue and its impact on outcomes. Finally, they will describe the selected intervention and how it fits with the chosen nursing theory.

Students will then formulate a clinical question in the standard PICOT format and identify key terms to conduct a literature search for relevant evidence-based practice (EBP) evidence. This assignment will help prepare them for the Week 7 assignment to foster a proposed EBP evidence-based intervention.

For the PICOT Worksheet, please use the provided form in Doc Sharing and complete it as you are conducting your search. Then, be sure to add notes after each step of the search. The worksheet is due by Sunday at 11:59 p.m. MT. Then, write a paper to describe your results.
